JINDAL AFRICA



Jindal Africa is a fast-growing and significant part of Indian conglomerate Jindal Steel and Power Limited, which in turn is part of the diversified O.P. Jindal Group, which is worth about US\$22 billion across the globe.

The African operations span through South Africa, Mozambique, Botswana, Namibia, Zambia and Zimbabwe and our strategy has shown significant results in improving the quality of life for the people, while nurturing the environment that has produced good quality Coal, Anthracite and is in the processing of setting up Power Stations and Iron Ore Mines.

In South Africa, the group runs an Anthracite operation in the Mpumalanga province, where it employs over 500 people directly. It's a state-of-the-art underground operation that has been running successfully for the past 14 years.

The group has been striving to develop an Iron Ore project in KwaZulu Natal, which aims to provide employment to more than 3000 employees directly when in operation. It would be one of the largest investments in the recent past in South Africa, when it realises its potential.

Significant progress has been made in Mozambique, where Jindal has been running a Coking Coal operation it has built and is under operation since 2013 and has been running its own set of locomotives and wagons for the coal transport. Jindal can proudly say that it successfully achieved a resettlement for hundreds of nationals who were to be relocated from the mine and has built a fully developed colony with 325 houses, including a hospital and school for the relocated. Giant strides were taken when Jindal acquired the Coking Coal operation from Vale in 2021, making it the largest coking coal producer in Africa, employing more than 10,000 workers directly and indirectly, with a significant contribution to the GDP of Mozambique. Very recently, Jindal has made forays into the Power Sector in Mozambique, with the commissioning of an 8 MW Coal fired Power Station at its coal mine, making it the first Coal Fired Power Plant of Mozambique.

The years long effort in Botswana bore fruit in 2023 when a PPA for Coal Fired Power Plant was signed with the Botswana Government. Jindal would be developing a 700 MW Power Plant to be completed in two phases of 350 MW each, with the first 350 MW Power plant to be completed by December 2026. It is believed this Power Station could service Botswana's requirement, in addition to alleviating some of the power supply issues in South Africa as well.

Under the dynamic leadership of Mr. Naveen Jindal, Chairman of the group, Jindal Africa's operations are headed by Mr. Parshant Goyal as its CEO who is driving all the projects and initiatives duly supported by his leadership team at various locations.
