Ikwezi Mining, one of the flag-ship entities of Oza Holding, produces around 3 million tons of coal annually. Ikwezi's mining complex entails several open pit operations, coal beneficiation plants and an anthracite calcination plant in the KwaZulu-Natal province of South Africa. The company has invested in excess of R 500 million over the past five years and continues to explore expansion opportunities in the coal mining sector. The company has generated full time employment of over 1500 individuals through its mining operations. Ikwezi Mining actively partners with host communities, investing in education, skills development, and community projects. The company is committed to meaningful involvement and sustainable economic upliftment of the local communities demonstrated through initiatives like the Ikwezi Community Forum and various community development projects. The company has invested more than R 50 million on various corporate social responsibility initiatives over the last five years.
